A key part of minimizing the transmission of COVID-19 is social distancing. Social distancing, also called “physical distancing,” means keeping space between yourself and other people outside of your home. Here are some simple guidelines on how to practice social or physical distancing:

- Stay at least 6 feet (about 2 arms’ length) from other people
- Stay out of crowded places and avoid mass gatherings



Social distancing can help keep you healthy, but it also might be a little frustrating and lonely at times. Most people think about what they can’t do in social distancing. Here are the Woodland Stompers sharing something that you CAN do! Social distancing fun.

If you wish to make a comment during general public comment or on a specific agenda item, there are two ways to do so. You may leave a voice mail message at (530) 661-5900. All voice mail messages received by 6:00 p.m. will be played during the City Council meeting and read into the record at the appropriate time. Any member of the public watching the live stream who wishes to make a comment on an item as it is being heard may submit an email to the City Clerk at [CouncilMeetings@cityofwoodland.org](mailto:CouncilMeetings@cityofwoodland.org) prior to Public Comment on that item. Email comments submitted to be read into the record shall be no more than three (3) minutes when read aloud. Please include the agenda item in the subject line.
