8. **SUBJECT: Sustainable Communities Planning Grant and Incentives Program**

**Recommendation for Action:** Adopt Resolution 6046 approving the submittal of an application of grant funds from Sustainable Communities Planning Grant and Incentives Program under Proposition 84 and authorizing the City Manager and/or his designee to execute all necessary forms on behalf of the City of Woodland.

On a motion by Vice Mayor Davies, seconded by Council Member Dote, and carried unanimously Council approved Resolution 6046, a “Resolution of the City Council of the City of Woodland Approving the Submittal of an Application for Grant Funds from the Sustainable Communities Planning Grant and Incentives Program Under the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006 (Proposition 84)”.

9. **SUBJECT: Lower Cache Creek Feasibility Study**

**Recommendation for Action:** Delegate authority to the City Manager to execute Amendment Number 1 to the Federal Cost-share Agreement and any future amendments to this agreement that are within the current scope and approved budget, and authorize an additional \$1.15 million to fund the Non-Federal Cost-share for the City of \$1.4 million.

On a motion by Council Member Marble, seconded by Council Member Dote and carried unanimously the Council delegate authority to the City Manager to execute Amendment Number 1 to the Federal Cost-share Agreement and any future amendments to this agreement that are within the current scope and approved budget, and authorize an additional \$1.15 million to fund the Non-Federal Cost-share for the City of \$1.4 million
