SUBJECT: Proclamation - Red Cross Month

Report in Brief

Each year the Yolo County Chapter of the American Red Cross has requested that the Council acknowledge their organization by proclaiming March 2010 as Red Cross Month. Ms. Donna Neu, Executive Director, will be present to receive the Proclamation.

Staff recommends that the City Council adopt a Proclamation declaring March 2010 as Yolo County Red Cross Month.

Background

Council had first issued a Proclamation for Red Cross Month in 2000. Although there had been a lapse in issuance for a few years, Council has again been issuing a Proclamation as recognition of the Woodland Chapter for their continuing efforts and accomplishments to those in need. It is appropriate for the Council to recognize them with a Proclamation in support of the activities. In addition, it is important to note that the Red Cross supplied dozens of volunteers for the flu clinics this year which were very critical given concerns regarding the H1N1 virus.

Recommendation for Action

Staff recommends that the City Council adopt a Proclamation declaring March 2010 as Yolo County Red Cross Month.

PROCLAMATION

RED CROSS MONTH – MARCH 2019

WHEREAS, for more than 100 years Yolo County residents have had a place to turn during times of disaster; and,

WHEREAS, when a disaster such as a fire or flood strikes, the Yolo County Red Cross responds with food, shelter, clothing, prescriptive medications and counseling, all as a free gift to the community as a result of nearly 500 Yolo County volunteers; and,

WHEREAS, the Yolo County Red Cross also cares about other communities and assisted our neighbors in the Midwest and South when tornados and hurricanes have devastated their homes and businesses; and,

WHEREAS, the Red Cross is a volunteer-based organization, drawing on dedicated individuals to provide education and emergency services, sometimes under very harsh conditions over many hours; and,

WHEREAS, Red Cross volunteers are diligent and treat their positions as a job even though they receive no monetary reward; and,

WHEREAS, the Yolo County Red Cross is dependable, financially accountable and provides a high quality of service to members of the community, including training 10,000 people per year in Cardiopulmonary Resuscitation (CPR), and First Aid, helping more than 200 military men and women in emergency situations, responding to single family fires and other disasters around the clock.

NOW, THEREFORE, the City Council of the City of Woodland does hereby proclaim the month of March 2010 as Red Cross Month and urges recognition of the appropriate activities and educational opportunities that have been held and will continue throughout the year by the Yolo County Red Cross in their efforts to benefit the entire Yolo County Community.
