YCOA is also discussing "observation status" that is used at facilities. Yolo 2-1-1 is making progress linking this directly to Yolo Senior Link. 

SUBJECT: Monthly Senior Center Report

RECOMMENDED ACTION: None. Information only.

BACKGROUND INFORMATION: The following provides highlights of the Senior Center since the last report.

Healthy Living Workshops: The Woodland Senior Center partners with the Yolo County Health and Human Services Department to offer “Healthy Living Workshops” led by the Yolo County Public Nurse Lisa Musser, RN. So far, Lisa has offered two workshop sessions on Preventing Falls (which had 26 participants) and Brain Health (24 participants). There are two scheduled workshops left, including Talking With Your Doctor and Avoiding Hypertension. Additionally, Lisa is working with Dignity Health to offer a Chronic Disease Self-Management Program for older adults with long-term health conditions. While the workshops are drop-in, the chronic disease program is by registration only (no cost).

Fall Prevention Festival & Flu Shot Clinic: The Senior Center partners with the home health care service organization Comfort Keepers to offer a “Fall Prevention Festival.” There will be an opportunity to learn from experts on topics like exercise, vision, home modification, and physical/medical issues related to falls. Public Health Nurse Lisa Musser, RN will be on hand to provide flu shots for seniors.
